5. Sealed or electronic bids must be submitted to the office Aathabis Municipality, Rakamkarnali Dailekh, Dailekh, Dailekh, Karnali Province, Nepal by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before 20-02-2024 12:00. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 20-02-2024 14:00 at the office of Aathabis Municipality, Rakamkarnali Dailekh Dailekh Dailekh Karnali Province Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs. 230000.0, which shall be valid for 30 days beyond the validity period of the bid.
