The "Letter of Technical Bid" submitted with Technical Bid, and the "Letter of Price Bid" submitted with Price Bid in separately sealed envelopes must be signed by authorized signatory, failure to which may be the ground for declaring the bid non responsive.
- 2. Only eligible bidders with the following key qualifications should participate in this bidding: Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 7,24,10,000.00/- (Without VAT)
- Minimum Work experience of similar size and nature (i.e. at least one RCC Building Construction Experience within last 10 years); Value of Service for Single Project shall be of at least NRs. 7,73,00,000.00/- (Without VAT)
