- 6. The bids will be opened in the presence of Bidder's representatives who choose to attend at specified date and time mentioned above at Aathabis Municipality, Rakamkarnali, Dailekh. Bids must be valid for a period of (45 days for sealed) after bid opening and must be accompanied by a bid security amount shall be valid (minimum 75 days for sealed quotation) for 30 days beyond the validity period of the bid.
